

TRANSITORY REGULATIONS (from the Academic Year 2022-23)**Preamble:**

The CBCS & OBE based regulations and courses (referred to collectively as R-22) introduced from the academic year 2022-23 have brought in significant changes in the course structure and academic regulation of the programs in the University as indicated below:

Considering the significant changes in all the aspects as indicated above, the following transitory regulations have been approved.

The following regulations shall be applicable for the students from the pre R-22 Regulations applying for re-admission:

1. Re-admission into 1st Semester of R-22:

Only students re-admitted into the full 1st Semester of R-22 will, for all purposes be subjected to the entire provisions of R-22.

2. Re-admission from 2nd Semester onwards:

- i. Students re-admitted from the 2nd Semester onwards will be subjected to the provisions of the pre R-22 regulations if still in force, in which they are first admitted. In case the pre R-22 regulations are not offered, the students shall be re-admitted into R-22 regulations.
- ii. Students re-admitted from the 2nd Semester onwards will be subject to the provisions of the R-22 regulations only. Once re-admitted in R-22 regulations, the students will have to fulfill all the academic requirements of R-22 regulations and shall pass out in the same regulations.
- iii. The student re-admitted into R-22 regulations, he/she has to complete all the courses from the semester of re-admission irrespective of the total number of credits secured.
- iv. Courses with similar nomenclature & syllabus already completed in R-17 regulations need not be repeated again in R-22 regulations. In all other cases the guidelines given for the approved list of equivalent subjects may be followed.
- v. Pending courses if any of R-17 regulations for the re-admitted students, have to be completed in R-17 regulations only.
- vi. Requirements of pre-requisites need not be followed for candidates re-admitted from R-17 to R-22 regulations.

3. Academic Regulations for Re-registration cases of Students admitted prior to 2022

- i. Students originally admitted in the pre R-22 regulations, may be assigned teacher/s wherever possible, to enable them to complete their internal assessment as per their pre R-22 regulations. Student has to complete the courses whenever offered. Special arrangement for the course/s may be made in case it affects the time line of the students' academic engagement.
- ii. Whenever there is a change of syllabi, end semester examinations based on the old syllabi will be conducted in order to enable the students to clear the backlogs.
