## 'Rules of Reservation'for admission into Under-Graduate and Post-graduate Programs for the Academic Year 2025-26

- 1. "Admissions to 85% of the seats shall be reserved in each course in the Educational Institutions in the State for the local candidates of O.U. Area as specified in the Andhra Pradesh Educational Institutions (Regulations and Admissions) Order, 1974 as subsequently amended and the remaining 15% of the seats shall be un-reserved seats, as follows:
  - i. All the candidates eligible to be declared as local candidates of O. U. Area.
  - **ii.** Candidates who have resided in the State for a total period of ten years excluding periods of study outside the State or either of whose parents have resided in the State for a total period of ten years excluding periods of employment outside the State;
  - **iii.** Candidates who are children of parents who are in the employment of this State or Central Government, Public Sector Corporation, Local Bodies, Universities and other similar quasi Public Institution within the State; and
  - iv. Candidates who are spouses of those in the employment of the State or Central Government Public Sector Corporations, Local Bodies Universities and educational institutions recognized by the Government or a University or Other competent authority and similar other quasi-Government institutions within the State.
- **2.** The statutory rules of reservation as per State Government are applicable as under
  - a) SC/ST/BC Categories
    - ➤ SC 15% (Group I 1%, Group II 9%, Group III 5%)
    - ➤ ST 10%
    - ➤ BC-A -7%
    - ➤ BC-B -10%
    - ➤ BC-C -1%
    - ➤ BC-D 7%
    - ➤ BC -E 4%
  - b) Special categories (Horizontal reservation in each category)
    - ➤ CAP 2%
    - ➤ NCC 1%
    - ➤ Sports 0.5 %
    - ➤ PH 5%

The following is the each category of disability at the rate of 1% each to the following categories:-

- a. Blindness and low vision;
- b. Deaf and hard of hearing;
- c. Locomotor disability including cerebral palsy, leprosy cured, dwarfism, acid attack victims and muscular dystrophy;
- d. Autism intellectual disability, **specific learning disability** and mental illness;
- e. Multiple disabilities from amongst persons under clauses (a) to
  (d) including deaf-blindness in the posts indentified for each disabilities.

## c) Reservation for women

- 33 1/3 % of seats reserved for woman candidates in each Program and in each category (OC/SC/ST/BC).
- **3.** 5% supernumerary seats of the approved intake in each program will be meant for students of other states under National Integration Scheme. Admissions in this quota will be applicable only to those candidates who have qualified in the MFA Entrance Examination -2025.
- **4.** 10% supernumerary seats of the approved intake in each program will be meant for Economically Weaker Sections (EWS).
