1. Sealed bids are invited for the auction/disposal of the aforesaid vehicles on the terms & conditions mentioned below.
2. Firms/Persons interested to buy the aforesaid vehicle are required to submit their bid in the enclosed proforma addressed to the Registrar, JNAFAU, Hyderabad 500028 **Phone No. 9700684742 and email registrar@jnafau.ac.in**. The vehicle can be inspected from 11:00 AM to 3:00 PM on all working days from **05.10.2024 to 10.10.2024**. The last date for bids is on **18.10.2024 till 05.00 PM**. The bids received will be opened by the Committee on **19.10.2024 at 11:00 AM**.
3. The interested Bidders may submit their bid in the prescribed format along with an Earnest Money Deposit of Rs.20,000/- (Rupees Twenty Thousand only) by way of Demand Draft drawn in favour of “REGISTRAR, JNAFAU, Hyderabad”. The bids received without **Earnest Money Deposit will not be accepted.**
4. The auction will be governed by the following conditions:-

(i) The successful bidder shall deposit the amount within three working days. The delivery of the vehicle will be given only after deposit of full amount of rate quoted and accepted by the University. The Successful bidder on submission of documentary evidence in support of identity and residential status (Ration Card/Voter Identity Card/Aadhar Card in case of Individual and Registration Certificate in case of firms etc.)

(ii) Auction process if any shall be subject to Jurisdiction in the Court of Hyderabad only.

(iii) The vehicle will be disposed off on “as is where is basis” and no guarantee for its worthiness or quality will be given by the University.

(iv) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The University will not be responsible for any lapse on his part in this regard. The Original Registration Certificate of the vehicle will be provided to the successful bidder, which has been issued by the Transport Department of Telangana State.

(v) The successful bidder shall not be allowed to withdraw his/her bid and in the event of on his/her part failure, his/her earnest money will be forfeited.

(vi) The sold vehicle shall be removed by the successful bidder within 72 hours of depositing the bid amount and at his/her own expenses otherwise a penalty of Rs.500/- per day will be charged. No assistance/transportation will be provided by the University. Permission to take out the disposed vehicle from the premises will not be allowed on holidays, Saturdays and Sundays.

(vii) The GST or any tax applicable to be levied will have to be paid by the successful bidder over and above his/her offer as per Government Rules.

(viii) Auction form should be signed in ink himself/herself or his/her by the authorized signatory only. Photocopy or unsigned bids shall be rejected.

(ix) If the tendering firm/person furnish any false or wrong information, they will themselves be liable for consequences if any along with forfeiture of earnest money deposit.

(x) Overwriting, erasures, corrections etc. in the prescribed proforma are prohibited.

(xi) The University reserves the right to accept or reject any/all of the bids without assigning any reason.
