All the qualified and eligible candidates are hereby informed to exercise web options (ONLINE) for Phase - II from 11th to 12th September 2025 at https://tsbfa.tsche.in/

1. Who should participate in Phase-II?

- a. Who secured a seat in the earlier phase of web based counseling and wish to move to some other course.
- b. Who secured a seat under Self Supporting Scheme (SSS/SF) in Phase-I and wish to move to regular seat in the same course.
- c. Candidate who participated in the earlier phase of web based counseling and could not secure a seat.
- d. Candidate who was allotted a seat in phase -I but didn't report.
- e. Candidate who was allotted a seat in earlier (Phase-1) but cancelled his / her admission.
- f. Candidate whose certificates are verified and declared eligible and could not exercise web options during Phase I.
- g. Candidate who did not participate in earlier phase of counselling even though he / she had been called for counselling.
- h. Candidate claiming reservation under special reservation category (PH/NCC/CAP/SPORTS) has to exercise options again in phase II to claim reservation under special reservation category.

2. The candidates may note that

- a. Options exercised for Phase-1 will not be considered for Phase 2. Candidate has to exercise options afresh for each phase of web based counseling through online at https://tsbfa.tsche.in/ only.
- b. In case if the candidate is satisfied with the previous allotment (Phase 1), options need not be exercised.
- c. Options may be exercised for those courses even if the vacancies are not available, as vacancies may arise due to sliding, cancellation and conversions.
- 3. If the candidate secures a seat in Phase II, he / she will lose the claim on the earlier allotted course.
- 4. Download the allotment letter on or before the date furnished in the allotment letter to report at the college. Failing to report in the college within the date furnished, the candidate will forfeit the claim on the new course as well as the old course.
- 5. There will be 'No second phase' counselling for NIS candidates.

Note: Candidate who couldn't attend Certificate Verification during Phase-I (or) those who like to update their pending certificates (if any) are informed to attend certificate verification and to exercise web options at the Office of the Director Admissions on 11th or 12th September 2025 (11:00 AM to 4:00 PM).
